Reference original ATI published on 18<sup>th</sup> October, 2018 and subsequent Amendment no. 1, following amendment is issued (applicable at all relevant sections of ATI):

### **1. Submission of Financial Proposal (under Chapter III – Financial Proposal -Price Bid Form).**

- i. Bidders have to submit only **Form Fin-2: Lump Sum Contract Price Online (Price Bid)** for quoting their Schedule wise Prices.
- ii. Rest of the Financials Forms i.e. **Form FIN I - Price Bid Form, Annexure-A to Form FIN-2 and Form FIN-3: Schedule wise Priced Bill of Quantity** are to be submitted **Offline** as given in the bid document (at page no. 59, 61 and 62-79).
- iii. The FORM Fin- 3 is the breakup of lump sum contract price and should match with total contract price quoted online. In case of any discrepancy in the total contract price quoted in Form Fin- 2 and Form Fin-3, the contract Price quoted online under Form Fin-2 (Price Bid) shall be considered as final and will be taken for evaluation and ranking purpose.
- iv. These offline filled forms should be submitted in sealed envelopes before **27<sup>th</sup> November, 2018 till 1430 hours** at Strategic Alliance Management Services Pvt. Ltd., B01-B03, Vardhman Diamond Plaza, Community Centre, D. B. Gupta Road, Paharganj, New Delhi – 110055.
- v. These financial forms submitted in sealed envelopes will be considered as integral part of the financial bids and shall be opened together with online financial bid on the date and time intimated later for technically qualified bidders only.
- vi. Non-submission of complete financial bids (both online and offline) shall lead to rejection of the bid.

### **2. Submission of Original Bid Security Instrument: Original Bid Security Instrument must be deposited at the Purchaser's address **up to 1800 hours on 03/12/2018**.**
