19.3 The bid security shall be in any of the following forms at the Bidder's option: a) Fixed Deposit Receipt (FDR) or Term Deposit Receipt (TDR) issued by Scheduled Bank in India; or b) Demand Draft or Banker's Cheque c) Bank Guarantee issued by a Scheduled Bank in India; or d) Deposit through Digital mode as specified in the BDS; or e) Any other form as specified in the BDS	19.3 Bidder will be suspended and declared ineligible for two years from the date of suspension, to submit bids / proposals against the Request for Bids / Request for Proposals issued by the Purchaser, in the following cases: (a) When the bidder withdraws or modifies its bid during the validity of bids as specified in the Letter of Bid; or (b) when the bidder, having been notified of the acceptance of its bid by the Purchaser during the period of bid validity, (i) fail or refuse to execute the Contract; or (ii) fail to furnish the Performance Security, if required in accordance with the ITB Para 37 of the Tender Document.
